

# Health Care FSA Eligible and Ineligible Expenses

Your Health Care Flexible Spending Account (FSA) dollars can be used for a variety of out-of-pocket health care expenses that qualify as federal income tax deductions under Section 213(d) of the Internal Revenue Code. Health Care FSA dollars can be used to reimburse you for medical and dental expenses incurred by you, your spouse or eligible dependents.

Below you'll find sample lists of expenses currently **eligible** and **not eligible** by the Internal Revenue Service. These lists are not necessarily inclusive or exclusive, and may be subject to change based on regulations, IRS revenue rulings and case law. It is solely based on our current interpretation of IRC Section 213(d) and is not intended to be legal advice.

The IRS now allows for the reimbursement of certain Over-the-Counter (OTC) items to be purchased with Health Care FSA funds. There is no need for a prescription or doctor's note. You may utilize your HG Advantage Card for these purchases.
